I understand that this release and waiver is intended to be as broad and inclusive as is permitted by law, and that if any portion of this release and waiver is held invalid, the remainder will continue in full legal force and effect. This release and waiver shall extend to and be binding upon me and my estate, heirs, executors, administrators and personal representatives.

I understand that my participation in the Event is completely voluntary on my part and permitted at Organization's discretion, and I agree to abide by all policies and procedures as established by Organization and whatever the prevailing practices at the time of meeting are. If my conduct does not meet reasonable standards of behavior, including without limitation following the instructions provided by Organization, I understand that my participation in the Event may be revoked.
