An Alpha Omega Alpha graduate of MCP-Hahnemann College of Medicine of Drexel University, Dr. Ilyas completed his Orthopaedic Surgery training at Temple University Hospital and his fellowship as a Harvard Fellow at the Massachusetts General Hospital in Boston.

#### ARI C. GREIS, DO

Clinical Assistant Professor, Physical Medicine and Rehabilitation/Rothman Orthopaedic Institute at Jefferson Director, Medical Cannabis Department at Rothman

Pain Management Physician for the Philadelphia Eagles

Dr. Ari Greis is a board-certified physician specializing in non-operative treatment of spinal and musculoskeletal disorders. As Director of

the Medical Cannabis Department at Rothman, his main interest is in the treatment of chronic pain with cannabis as an alternative to opioids. As a Clinical Assistant Professor of Rehabilitation Medicine at Thomas Jefferson University, Dr. Greis is widely published and continues to teach residents and medical students. He is fellowship trained in sports and spine rehabilitation and performs fluoroscopic guided spine injections, ultrasound guided peripheral joint injections, trigger point injections, and electrodiagnostic testing.



#### ABRAHAM J. KABAZIE, JR., MD

Vice Chairman, Dept. of Anesthesiology and System Medical Director/Allegheny Health Network Division of Pain Medicine

Pain Medicine Fellowship Associate Program Director and Clinical Assistant Professor/Temple University School of Medicine

Dr. "Jack" Kabazie, Jr. is a triple-boarded specialist. Certified by the American Board of

Anesthesiology for pain medicine and by the American Board of Preventive Medicine for addiction medicine, he helps patients manage their pain with patient-centered, individualized care. He is registered with the state's medical marijuana program to issue certifications to eligible patients. Dr. Kabazie is also trained in medication-assisted treatment for opioid use disorder using Suboxone<sup>®</sup>. He is widely published and has lectured extensively on pain medicine and addiction at national, regional, and local meetings, and currently sits on the board of directors of the Pennsylvania Pain Society.



#### J. DEANNA WILSON, MD, MPH

Assistant Professor of Medicine, Pediatrics, and Clinical and Translational Sciences/University of Pittsburgh Department of Medicine/School of Medicine

Dr. Wilson's research interests are focused on reducing substance use-related health disparities and building equity for vulnerable populations with substance use disorders, particularly young

people who inject opioids. Her work broadens our understanding of the development of opioid use disorder following first opioid prescriptions in youth. Her research leverages health services research, implementation science, and community-engaged methods to examine how best to integrate harm reduction into primary care settings, develop low threshold models of care to improve engagement and retention of vulnerable populations, and improve engagement and retention of adolescents and young adults in opioid use disorder treatment.



#### HEATHER L. RICHARDS, MD

Dr. Heather Richards currently sees patients as an Allegheny Health Network primary care physician and treats patients at the AHN Positive Health Clinic. Board certified by the American Board of Internal Medicine, she attended
