



# 2018 Workers' Comp Increase is 3%.

Effective January 1, 2018 workers' compensation fees are generally equal to 233.6% of 1994 Medicare rates with the exception of new and revised codes.

## 2018 WC Fee Schedule

Check your actual workers' comp reimbursements against what they should be, according to law.

### Notice to Practices Who Have Ordered the WC Fee Schedule in Prior Years

You are advised to order a new fee schedule each year because your old one will not contain fees for **new and revised** codes. Therefore, revising your old fee schedule will result in inaccurate information. In addition, you should be aware that code ranges from the 2018 WC fee schedule can be downloaded in HTML or PDF formats from the Bureau's website ([www.dli.state.pa.us](http://www.dli.state.pa.us)) at no charge. **HOWEVER, IT IS NOT IN THE SAME FORMAT, NOR AS USER-FRIENDLY AS POS PROVIDES.** The Bureau's version includes all 4 geographic areas and *it does not contain any decimal points.*
